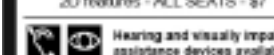

For many, this may be the only time they have been around a table for a meal without drugs, alcohol, abuse, or trauma. I am forever impressed by the generosity of people in the communities that we serve and their desire to donate. # JOHNSON

The most important positions in our community, the County Attorney and the Assistant County Attorney, are the chief law enforcement officials of the county. The County Attorney is responsible for the direction and control of the prosecutorial function in his or her jurisdiction. The primary responsibility of the prosecutor is to seek and obtain justice as he or she works closely with law enforcement professionals, other attorneys, and community resources

Recently in Buena Vista County, Ashley Herrig, one of the candidates for Clay County Attorney, entered a plea agreement for a man who was charged with 10 felony and misdemeanor charges including sexual abuse, lascivious acts with a child, indecent contact with a child, incest, assault with intent to commit sexual abuse and child endangerment, with a potential to result in up to 87 years of imprisonment. Part of the normal process means that the charges were reviewed and determined by the Storm Lake Police Department, Mercy One Siouxland Child Advocacy Center, Iowa DHS, and as part of her duties as an attorney representing Buena Vista County, reviewed by Ms. Herrig as well prior to proceeding. The defendant was held in the county jail with bond set at \$134,000. Buena Vista Assistant County Attorney Herrig negotiated a plea agreement that resulted in the dismissal of all charges except for a simple misdemeanor assault charge, a \$105 fine, and 30 days in jail with credit for time served. Dismissal of charges does not mean that the charges were invalid.

When asked, Buena Vista Assistant County Attorney Ashley Herrig declined to specify the details that were considered in plea negotiations. Her response via email to the Storm Lake Times at the time was: "I can let you know that the plea obtained justice in accordance with the standards outlined by the Iowa County Attorney Association's Prosecutorial Standards". No statement has been issued since.

Certainly, circumstances can exist that would cause a plea agreement to be negotiated. That being said, it is also true that a community is owed an explanation, particularly in cases where the safety of children is a concern, where the whereabouts of the person at fault is a concern, and most of all, when the health and wellbeing of the victims is a concern. Ms. Herrig had, because of the scope of her office, opportunity to exercise transparency and accountability, and still provide an answer that would protect the privacy of the individuals involved. Her response fell short. These are not meritless concerns; it is a statistical fact that people who commit crimes such as those described in this case, go on to repeat those same crimes again in the future. It is reasonable to expect that a public employee charged with ensuring the safety and wellbeing of the community, should provide better answers and more transparency.

The task of protecting our community and its citizenry sets a high bar, and demands accountability, responsibility, and ethical standards. We believe that our community deserves the best legal representation possible, and we've had the good fortune to experience the quality of Clay County Attorney Travis Johnson's work, in his relationships with our community leaders, our children, law enforcement professionals, human services workers, and so many more. He has also given selflessly of his personal time to make a difference, and can be trusted to be available, honest, knowledgeable, and respectful.
